#### **ORDINANCE No. O-221206**

# AN ORDINANCE EXPANDING THE DISTRICT, IN ORDER TO ALLOW ADJACENT LANDOWNER TO CONNECT TO WATER AND SEWER SERVICES WITHIN THE DISTRICT.

<u>Section 1.</u> <u>Statement of Purpose.</u> The purpose and intent of this Ordinance is to expand the District to include certain adjacent land, commonly referred to as the <u>Sierra Vista Addition</u>, and which is intended to be known in the future as Sierra Vista Subdivision, Phase 1.

<u>Section 2.</u> <u>Legal Description of Annexed Land.</u> The current legal description of the land to be included into the District is set forth in **Attachment A**.

## Section 3. Ordinance.

WHEREAS, Section 7-13-2341(5) M.C.A. provides that if the Board of Directors has received a petition for annexation from contiguous property owners, and determines that the District has a water facility or a sewer facility with a capacity greater than required to meet the needs of the current District, then with the written consent of the contiguous property owners to whom the service is to be extended, the Board of Directors may by ordinance expand the District to include the contiguous land and grant said petition for annexation; and

WHEREAS, the Board of Directors has received a petition for annexation from contiguous property owners attached hereto as **Attachment B**; and

WHEREAS, the Board of Directors has duly determined that the District has the sewer and/or water facility with a capacity greater than required to meet the needs of the current District;

**NOW THEREFORE, BE IT ORDAINED** by the Board of Directors of the RAE Subdivision County Water and Sewer District No. 313 that the within ordinance be adopted as written, and that the District shall be and is hereby expanded to include the real property described in **Attachment A**.
